

#### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline:

- ISO 14001 certification
- The digital forensic laboratory is undergoing an in-depth programme of equipment replacement to operate on the most energy efficient infrastructure including imaging, processing and analysis workstations. One example is where our current ten imaging machines will be reduced to six imaging stations by using more powerful and energy efficient models.
- Utilisation of online interviews as a key stage of the recruitment process to reduce the environmental impact of inviting multiple candidates in for a stage one recruitment interview
- Staff travel for face-to-face meetings is only undertaken as a last resort with videoconferencing applications used wherever possible

IntaForensics is embarking on a number of carbon reduction initiatives which include:

- Investment in the self-generation of electrical energy through the installation of photovoltaics (PV), commonly known as solar panels
- Electrifying the company fleet of vehicles
- On-going project to assess the feasibility of adopting a cloud-based solution for technical operations thereby reducing the number of physical machines in the building and reducing the company's electricity consumption
